Driving restrictions, goods transport Germany

Vehicles concerned trucks with a total permissible weight of over 7.5t, as well as trucks

with trailers; The driving ban only applies to fright transports that are used for the business-like or paid transport of goods, including

associated empty journeys.

Area throughout the road and motorway network

Prohibition Sundays and public holidays from 00h00 to 22h00

Additional restrictions (summer)

Area the following stretches of motorway and trunk roads:

A 1	from the intersection Erfttal via intersection Leverkusen-West, Wuppertal, the Kamen intersection and Münster to the junction Lohne/Dinklage
A 2	from the Oberhausen intersection to the Bad Oeynhausen intersection
A 3	from the Oberhausen intersection to the Köln-Ost intersection, from the Mönchhof intersection via the Frankfurt intersection to the Nürnberg intersection
A 4	from Kirchheimer intersection to the Thuringia state border at Herleshausen
A 5	from intersection Hattenbach to Bad Homburger intersection, from Darmstadt intersection to the Karlsruhe-Süd junction and from the Offenburg junction to the Neuenburg interchange

A 7	From the Schleswig/Jagel junction to the Bordesholm interchange, from the Soltau-Süd junction to the Göttingen-Nord junction, from the Schweinfurt/Werneck junction via the Biebelried interchange, the Ulm/Elchingen interchange and the Allgäu interchange to the end of the federal border in Füssen

Prohibition: Saturdays between 1 July and 31 August from 07h00 to 20h00

For the summer driving restrictions 2023 in Germany, the BGL alternative route map gives a quick overview of the affected routes and the existing alternative routes. The map was created in consultation with the responsible traffic authorities and exists, in a PDF-format Karte BGL-Ausweichstrecken 2023 (final - web) (bgl-ev.de)

The digital version, an interactive map called "Autobahn app", can be used via smartphone or tablet. It is available for many countries as Android and IOS and can be downloaded from the Bundesverband Güterkraftverkehr Logistik und Entsorgung (BGL) e.V. (bgl-ev.de)

Exceptions (apply to both of the above restrictions)

- Combined rail/road goods transport from the shipper to the nearest loading railway station
 or from the nearest designated unloading railway station to the consignee up to a distance
 of 200km (no limitation on distance during the additional summer restrictions); also
 combined sea/road goods transport between the place of loading or unloading and a port
 situated within a radius of 150km maximum (delivery or loading).
- 2. Deliveries of fresh milk and other dairy produce, fresh meat and its fresh derivatives, fresh fish, live fish and their fresh derivatives, perishable foodstuffs (fruit and vegetables).
- 3. Transport of animal by-products acc. category 1 acc. Art. 8 as well as category 2 acc. Art. 9 f) i) of regulation (EG) No. 1069/2009
- 4. Use of recovery vehicles, tow services and breakdown vehicles in case of an accident or any other emergency
- 5. Transport of live bees
- 6. Empty vehicles in connection with transports mentioned under point 2-5
- 7. Transport operations using vehicles subject to the Federal Law on the obligations of

service; the relevant authorisation must be carried on board and produced for inspection on request.

Also exempted from the prohibition are vehicles belonging to the police and federal border guard, fire brigades and emergency services, the federal armed services and allied troops.

For operations which are not covered by the above-mentioned exceptions, authorisations must be obtained. These, however, will be issued only in the event of an emergency, when delivery by other means of transport is not possible.

Night driving restrictions

There exist a certain number of night driving restrictions on specific routes. These are indicated by road signs.
